	Building Code Officials in New Jersey have significant responsibilities enforcing municipal construction codes and floodplain ordinances. With new regulations, updated flood mapping and ongoing construction activities in New Jersey communities, Code Officials face mounting challenges in their day-to-day work. This training will provide up to date information regarding codes, standards and requirements, and substantial damage determinations, as well as suggestions on how to manage the ever- increasing work tasks that come with the job.

A policy was put in place to help accomplish both after a Presidentially Declared Disaster through FEMA's Public Assistance Program. Certain building code and floodplain management activity expenses are now eligible for reimbursement under Section 1206 of the Disaster Recovery Reform Act of 2018. This workshop will include guidance on how communities can get financial assistance for eligible expenses, including labor costs and contracted services, and how being prepared ahead of time will help manage post-disaster floodplain management and building code activity demands.
